• Making Progress

o **Bike Share.** Bike share is an innovative transportation program, ideal for short distance trips where users have the ability to ride a bicycle at any self-serve bike station and return it to any other bike station located within the system's service area. The Baltimore City bike share system will be an affordable, healthy, safe and environmentally sustainable addition to the City's existing transportation network. The first equipment purchase order is expected to be completed by the end of this week, with subsequent equipment orders being placed once the Department of Transportation (DOT) receives federal and state grant approval. Two Bike Share Kickoff Meetings are planning for May 3rd at Patterson Park and May 10th at Franklin Square Park to showcase the bikes, start their survey to determine pricing, etc. and start gathering station location suggestions. DOT's Bike Share planning website will also go live in May showing pictures of the equipment, provide detailed FAQs of the process, and have a section where citizens can get involved (survey, comments, station suggestions). The remaining station locations will be determined once DOT gets feedback from the community this spring and summer.

o **Signage.** The Department of Transportation is responsible for installing and replacing missing and faded signs. CitiStat monitors all requests that come into the 311 database along with how long it takes to close out these request.
